Mark suggests that since only one location was tested for infiltration rate, the Board should require other locations to be tested. He also requests 20% void on rain gardens. Courtney has been consulted, there is an existing water shut off at the road and each building will have it's own shut off valve. The front roofs will be be directed to the rain gardens or drainage area. Downspouts will be 6 inch solid pipe. Water and Sewer lines will be 2 feet apart. Mark and Ryan have been corresponding for the last month hashing out all of the details.
