## 2. Z2024-094 Relief of 15 feet from Side Yard Setback for Shed

Mr Guynup explains that the home had a 12x12 drop off shed delivered for the residents to use as a smoking shed. The shed blocks the view to the street while the residents sit inside the main building. They would like to move this smoking shed off to the side to allow the residents to enjoy their view. Ms Ashline is seeking a 15 foot relief from the sideyard setback.

Currently the residents smoke 8 feet from the fence, and the Valhaven Main building is already inside the setback on that side.

The application is found to be incomplete and the map needs to be updated. After many questions and some discussion, the following list are things that need to be addressed; A proper map, photos of the shed, proposed ventilation of shed, photos of smoking area now, show how this variance would improve the present situation, and placement of shed on the map.
