Mr Guynup explains the application, he reads aloud the Town Law definition of an Off-Premises Sign. If the sign is approved, the applicant has another agenda item for a 7 foot relief for same sign.

The sign presented in the application is a large sign, unlike a directional sign which should be much smaller. This off premises sign was NOT brought up during the initial site plan review for the Storage Units. The present storage units are very close to being completely rented, which makes a wayfinding sign seem almost unnecessary, especially with modern GPS. The Town Law reads that off premises signs "May be" approved, not "Shall be." Neighboring land owners speak up, there is confusion as to who actually owns the land the proposed sign would be on.

New fill will be brought in to build the addition. Gutters will be installed and run underground to the ditch along Peasleeville Rd.
